

Stephen Sloan is a public historian specializing in post-1945 U.S.

history, environmental history, and community history. He holds a doctorate in public history and U.S. history from Arizona State University. Stephen is the director of the Institute for Oral History at Baylor University, one of the nation's premier academic oral history research programs. Stephen's previous post was the co-director of the Center for Oral History and Cultural Heritage at the University of Southern Mississippi from 2003 to 2007. Dr Sloan has led dozens of academic and community-based oral history research projects on a wide range of topics, from World War II to Hurricane Katrina, in work funded at the local, state, and national level.

Partnerships

Recently, I have been noticing how many customers come to the library with someone. The "someone" might be a spouse, a sibling, a relative, or a friend. People come together to the library for many reasons. They might just want to drive to the library together to share the

cost of gas, in a quest for a shared family member, a shared interest in genealogy, or maybe because they share a common goal. If they share a common interest, goal, or desire, often the partnership produces a more robust and useful end product than if either partner did the project alone.

The *Clayton Town Crier* has been very successful because of all of you, our subscribers. It is so successful that its number of subscribers is second only to *Upcoming HPL Events* out of the 36 electronic newsletters offered by HPL. We have achieved this distinction because of the interest in the Clayton Library and its collections by all of you, our subscribers. We thank you very much for such wonderful bragging rights!

We know that family history researchers do not just utilize genealogy collections. Manuscript collections, local history collections, and other special material repositories are always on a genealogist's radar. These collections – known as "Special Collections" are crossutilized not only by "us," but also by historians, archivists, architecture researchers, and frankly, anyone interested in the disciplines of genealogical, historical, archival, or preservation research. The Clayton Library is one of three Special Collections Units in the Houston Public Library system. The other two units, the Houston Metropolitan Research Center (HMRC), and the African American Library at the Gregory School also house historical and archival collections that might be applicable to your research.

A New Partnership

Because the *Clayton Town Crier* and the *Clayton Extra* do enjoy a large number of subscribers and because special collections users do cross-utilize many repositories, the editorial staff of the *Clayton Town Crier*

is announcing a new partnership. Beginning with our next issue, the *Clayton Town Crier* will be combining with the Texas and Houston History e-newsletter from the HRMC, and adding information from the African American Library at the Gregory School to bring you a new HPL Special Collections e-newsletter.

To better serve our customers and to highlight collections in all 3 units, the new newsletter, yet to be named, will come directly to you as the *Clayton Town Crier* and the *Clayton Extra* have, and will contain much of the same material we have been writing. Information about our current and new collections, highlights of sources, and information about our programming will all still be there. The added value comes from information regarding collections housed in our other locations.

The three special collections, Clayton, HMRC, and Gregory, do hope you enjoy the additional information you will begin receiving in October. The decision to bring this to you was all based on providing our readers information that we hope you can use in your research.

The Strongest Partnerships

Her research for Scots-Irish and Native American pedigrees from this Triangle, although difficult to document, is especially successful. She is experienced in New York research, tracing ancestors from New England and New Jersey across New York into Pennsylvania, Ohio, and Tennessee. And, she is skilled in researching English, Scottish, Irish, and Swiss German ancestors.

Arlene was one of the founders and original trustees of the Association of Professional Genealogists serving as president, 1980-1982, and as editor of the APG Newsletter and Green Sheet, 1982-1985. She currently edits four serials: *Research News, Immigration Digest, Virginia Genealogy Notebooks*, and *Researching Your Roots in New York* (with Linda E. Brinkerhoff).

Acquisitions Committee Report

With the help of Lesley Douthwaite, who is going through the Clayton Library 'want-list' and providing us with a list of materials the Library would like to have, we continue to place orders. There are books to check in on almost all of my weekly trips to the Library. Be sure to check our new materials list in the newsletter or on the shelves of new books at Clayton to see the variety of items that are being added.

We have been asked to purchase the remaining 39 rolls of microfilm needed to complete the *Naturalization Records of U. S. District Courts in the Southeast, 1790-1958* (M1547), and they will be ordered soon. Meanwhile, we have been notified that the approximately 1900 rolls of National Archives microfilm Clayton requested, when they were offered for the cost of shipping, are ready to be shipped. We agreed to pay for the postage and have arranged for that payment. Although I am not aware of all that is included in this shipment of 23 boxes of microfilm, I

know it will contain the 1930 Soundex that Clayton does not own, some passenger and immigration records, and possibly some military records. Normally this film sells for \$85 per roll, so you see what a special acquisition this was for the Library. We are happy that CLF was able to help the Library take advantage of this offer.

The family history authors who have been asked to donate copies of their publications since our last Newsletter have been very generous. These books are added to Clayton's family history collection for the price of a couple of stamps. We really appreciate the generosity and support of these donors. Facilities and Landscape Report --

In November of 2008, CLF was able to get the City of Houston (COH) to agree to re-roof the main library building as part of their "up to \$1,000,000" contractual obligation with CLF for the main renovation project. The re-roofing had been budgeted by HPL for several years in the future, but it would be moved up to the next fiscal year for our benefit. We were willing to allow this work to be part of the COH obligation because there was simply no other way to get the full expenditure of the obligation and Clayton would have the needed work done sooner than scheduled. That's always a good thing in dealing with a 25 year old roof. The amount of the roof replacement in 2008 varied depending upon the roof system chosen, but it would be \$175,000 (COH system and estimate) to \$250,000 (CLF system and estimate).

The next fiscal year came and went, with only reports to CLF that COH had hired a roofing consultant. Verification of the contract was sent to CLF but no progress documentation was ever provided that the design work was underway.

After that, the COH budget crisis arose and has been continuing for the first six months of 2011 (fiscal 2012). Apparently the roofing consultant had been put on hold. In speaking with the HPL Project Manager on 06/14/11, the funding for the re-roofing work has been released including an increased scope of work, which includes:

- Removal of existing flat roofs on the main library building, repair of existing substrate as necessary, installation of new roofing system.
- Increase quantity, or capacity of existing, overflow scuppers in the parapets surrounding the flat roofs.
- Re-working of the parapet cap course with new flashing installed there as well as where the flat roofs intersect the second story volume of building.
- Remove, clean, and re-caulk all existing windows and building expansion joints.

- Re-point brick mortar joints as necessary. Hairline cracks are not included.
- Install exterior roof access in the library service area for future ease of roof maintenance.
- Pay for extra on-site observation services by the roofing and waterproofing consultant during this work, including weekly or bi-weekly reports which include photographs.

COH and HPL have committed up to \$349,000 for the design services, construction, and observation of this work. CLF will not have to visit the site during the work except for a final "walk-thru" once completed. The work began in July. Both the roofing and waterproofing consultant and the roofing contractor for this work have been selected using COH approved consultant and contractor who have both performed to HPL's satisfaction on previous projects.

Additionally, COH and HPL have contracted with an architect to address the problem of the ponding water at the front drive on Caroline. While the design firm's answer to the problem has not been decided yet, HPL has made suggestions on what they believe are satisfactory solutions. The design work and permitting will continue throughout the summer and actual construction is expected to commence in early fall. Both the architect and contractor for this work have been selected using COH approved consultant and contractor who have both performed to HPL's satisfaction on previous projects.

The mailboxes have been installed in the CLF offices, but the HPL Project Manager has rejected the workmanship. Steps are being taken to remedy the situation so that the mailboxes have the appearance of the design submitted in 2009 by CLF.

"Clayton Has It -"

We often mentally separate the internet and the library, and forget that they can work together beautifully. For a number of years I have been trying to 'jump the pond' back to Ireland with my 1848 immigrant family. With the help of a couple of distant cousins whom I've never met or spoken to other than by e-mail, we are finding occasional clues and records in strange places. Since there doesn't seem to be any family bible, diaries, etc we are easily excited over the smallest verified discovery. For many years it seemed as though great-great-grandfather Revell had no siblings or parents. We now think we have some solid clues on both. Last week Suzanne mailed me copies of two letters written in 1827 and 1829 from a 'John' in Kildare, Ireland to 'Francis Henry' in Ohio. We'd never heard of a Henry in the family but every generation had at least one Frank and a John. The letters had been found in a 40-item archive collection at Duke University (North Carolina). No, none of this branch of the family had resided in the south – until the lady with the letters became a faculty member at Duke and donated the papers to their library.

Anyway, to make a long story shorter – I now had the name of a new person to try to connect to the family tree. So, I googled his name – Francis Henry Revell. Right at the top of the hits was the information that he was mentioned in a book, *Gateway to the West* by Ruth Bower and Anita Short. The next step obviously was to find that book. I hope that everyone is familiar with WorldCat.org. It is an on-line directory for finding which libraries have a particular book. I keyed in the book title and found several listings, and then I told the

computer to search locations. Of course Clayton had it, but it was now late Saturday afternoon and I'd have to wait until Tuesday to see if I had discovered a treasure. Also, since the library was not open I was relegated to trying to find them online in the census – no luck. Another husband, wife and 9 kids had evaporated into the world of incorrectly transcribed microfilm.

Tuesday morning arrived and I was there to help the librarians open the Clayton library. Back to the Ohio section, and there was *Gateway to the West* – a 2-volume set with each book about 3 inches thick. It was an indexed bound compilation of a now defunct genealogical publication. In the introduction, it was described as "...it managed to cover some of the least accessible yet most important genealogical records of 76 of Ohio's 88 counties... [including] common pleas, court records, guardianships, naturalizations, and deed abstracts...births, marriages, deaths, cemetery records, wills..."

My new-found treasures included Francis' obituary (9-9-1852), and two 1823 records of US Land Patents for 316 and 162 acres of land – in his name. (He had arrived in the US in 1818.) This book also contained a record of a guardianship case for Frank's daughter's future husband. And, of course, a transcription of their listing in the 1850 census. I had not found the entry online because 'Revell' had been transcribed as 'Rood'.

An added bonus to this adventure, the CLF project of 'A Book From Every County' meant that since I now knew where this family lived, I could also learn about their county, Preble County Ohio.

Houston Public Library increases their on-line database subscriptions –

One of the newest additions to the Houston Public Library free database subscriptions is *African American Heritage*. It is described as "A groundbreaking digital resource exclusively devoted to African American family history research. This collection was created in partnership with leading African American genealogists to develop a comprehensive mix of resources, records,

and tools specifically pertaining to African Americans."

To access this new treasure go to the Houston Public Library web page – www.hpl.lib.tx.us/home, click on 'research', and then scroll down to your selection. A click on African American Studies will expose a number of related databases.

People who remember our CLF push to fund the 1930 census purchase ten years ago are asking about the 1940 census. It will be released Monday April 2, 2012, but it appears that it will not be produced as rolls of microfilm. The word is that the National Archives plans to make scans of the census schedules and maps searchable online and available for download. No specific decision has been made, but it sounds like they are looking for a 'vendor' who will do the work for free and then charge the public a fee to access the records. Therefore, at the present time, it would appear that CLF will not need a dedicated drive to acquire the census for our library film drawers.
