A Clayton Library Treasure – The Cuban Papers

Navigating 100 reels of microfilm can appear extremely daunting. However, it is possible. Here are a few examples of how to find information on an ancestor from the eastern seaboard of the United States that migrated south and/or west during the Spanish Colonial period. As a brief review, the British held North-West Florida at the end of the French and Indian War. Many British subjects migrated to this area which included Natchez, Baton Rouge, and Mobile. British West Florida included Alabama, Mississippi, and went all the way to the Mississippi River. During the first three quarters of the eighteenth century, there were very few Anglo-Saxons living in the lower Mississippi Valley. This fact was radically changed during and after the American Revolution. The Loyalists came first seeking protection; the new Americans arrived next seeking land and fortune. ¹

Using Roscoe Hill's index to the collection, you will find many documents that provide clues to these settlers. There are four censuses for Baton Rouge. These can be found under the subject Baton Rouge in the index. The first two censuses are for the years 1782 and 1786 and they are in Legajo 192. The 1795 census is in Legajo 34, and the 1805 census is in Legajo 142. These documents have been previously published in several Louisiana periodicals. Seeing the original documents, in this case in French, and how readable they are is worth the time.

Scrolling through Legajo 2361 earlier this year, I came across a list of American and Irish immigrations to Natchez in 1788. They include arrivals from Kentucky, Pennsylvania, Cumberland, the Choctaw Nation, and Connecticut. I was very excited about this list and in a recent conversation with Winston De Ville, I mentioned finding it. Winston replied that he had previously published this. I went looking and found it in a March 1967 issue of the *Louisiana Genealogical Register*. That is more than 50 years ago! Winston said that his method of searching through the reels was much the same as I am doing now. He would scroll through a reel until he saw a date or name that caught his eye, and then stop and look. Winston said there are still many items that need to be retrieved. A list of De Ville's Cuban Papers retrievals is in his *An Annotated Bibliography of Genealogical & Other Writings, 1959 to 2012*. I found that a list of British settlers in three sites on the Mobile River was not among them. These were settlers in May 1780 that declared their neutrality after Galvez captured Mobile. It was found in Legajo 2359.

One of the most interesting letters found dating from 1790, was from a James Morrison of Virginia, writing to Governor Estevan Miro in New Orleans. Mr. Morrison was working on a survey of an area of salt springs along the Rio Rouge. Morrison asked Governor Miro for an exclusive right to mine salt and develop a salt works. As soon as Mr. Morrison completed the survey he planned to return to Virginia and within six months time return with his family. This can be found in Legajo 121. An internet search for James Morrison revealed a great deal about his business activities along the Mississippi River. The Missouri History Museum holds a collection of Morrison family papers which includes information on the Salt Trade established by James Morrison and his brother Jesse. In about 1804 the brothers leased land near Franklin, Missouri and began producing salt in partnership with brothers Daniel Morgan Boone and Nathan Boone. At this time, the brothers were living in the Saint Charles, Missouri area. ²

As these examples demonstrate, the informal title of this collection of microfilm, the Cuban Papers does little to reveal the variety of historical contents held within.

Carlos de Grand Pre

Pictured above is the list of arrivals at Natchez for December 21, 1788 signed by Carlos de Grand Pre, Commandant at Natchez. Notice the spelling of de la Nacion Chacta, Kentucky and Pennsylvania as a reflection on the slight variations of surnames that may occur in the document. As De Ville noted in his 1967 article, "The researcher should remember that the scrivener was a Frenchman, commanding a Spanish post, trying to write Anglo-Saxon names."¹

Proposed Changes to the CLF Bylaws –

In 2012, five years ago, the Clayton Library Friends membership voted to approve an updated version of their Bylaws. The three-member Bylaws Committee had addressed a number of areas that needed to be updated since the last revision many years ago. In 2014 the CLF Executive Board recommended a couple of additional changes and these were passed by the membership at the August 2014 CLF General meeting. Since then, a few more Bylaws adjustments have been recommended, and approved, by the CLF Executive Board.

The CLF Executive Board is recommending the following updates to the Bylaws.

Article VI, Section 6.3 – Executive Board:

The Board proposes to delete the requirement that voting members be ~~present~~ in person+ at Board meetings. With today's technology, the CLF Board has the technology to let members with time conflicts ~~attend~~ Board meetings via electronic means.

Article VII – Officers and Directors:

Section 7.1:

Change last portion to read: No officer shall serve more than two consecutive full terms in any one position except Treasurer. Delete ~~No officer shall serve more than six consecutive years on the Executive Board.~~ This deletion is similar to the following change.

Section 7.2:

Delete ~~No director shall serve more than two consecutive full terms, as a director, or more than six consecutive years on the Executive Board.~~ This would make it possible to retain enthusiastic Board members with particular skills suited for their Board positions . i.e. computer/website skills, acquisitions.

It will be the responsibility of the Nominating Committee to maintain the flow of Board members and to make recommendations for replacements when necessary.

Article VIII, Section 8.1 – Duties of Officers and Directors:

Delete sentence ~~The President shall only cast a vote at Board meetings to break a tie.~~ This is in conflict with **Article VI, Section 6.2 – Executive Board** that states ~~The Board shall consist of eleven voting members: five officers and six directors.~~

Also, the following minor ~~housekeeping~~ adjustments need to be made:

Article VI, Section 6.1 . change the last two words from ~~the Bylaws.~~ to ~~these documents.~~

Article VII, Section 7.3 . line 2 -- change punctuation of ~~Board. Excepting~~ to ~~Board, excepting~~ and punctuation of ~~President in~~ to ~~President. In~~

Article VIII Section 8.1 . 3rd to last line . delete ~~Webmaster.~~ it's now a Board position

Article VIII Section 8.2 . line 3 . change ~~is~~ to ~~an~~ . to read ~~in the event of an inability to act.~~

Article IX, Section 9.1 . delete ~~Facilities and Grounds (ending Jan 1, 2016) . Director~~

Article IX, Section 9.3 . add comma to read ~~is~~ authorized, as needed.

Article IX, Section 9.4 . delete ~~Webmaster.~~ it's now a Board position

Tom Coughlin -- Treasurer








